Methods Committee on Antimicrobial Efficacy Testing

Focus: Methods for efficacy testing and antimicrobial products, including preservatives, disinfectants, sanitizers, sporicides, Virucides and products used as decontaminants.

Methods Committee on Biological Threat Agents

Focus: Methods for detection and identification of biological threat agents microbiological and microanalytical analytes from a variety of matrices. Also, provide expert advice to other committees working on methods using threat agents.

Methods Committee on Food Nutrition

Focus: Methods for analysis of fiber, fats, minerals, sugars, vitamins, and nutrients in foods; and in the analysis of the commodities infant formulas and medical diets.

Focus: Methods for analysis of chemical and microbial pesticide formulations and disinfectants.
