CALL FOR METHODS

(DEADLINE: February 11, 2022)

AOAC INTERNATIONAL (AOAC) invites method developers to submit methods for consideration and possible evaluation through the AOAC *Official Method* program. Prospective methods must be able to determine *Carotenoids (alpha-carotene & lutein), Chlorates/Perchlorates, Fluoride, HMO (2'-FL, 3'-FL, 3'-SL, 6'-SL, DFL, LNnT & LNT) and Phospholipids* in all forms of infant, adult, and/or pediatric formula (powders, ready-to-feed liquids, and liquid concentrates) according to each nutrient's *Standard Method Performance Requirements (SMPRs®)*.

The AOAC Official Methods Program organizes and facilitates the review of methods by appointed ERPs across AOAC's integrated science programs. Methods submitted through an active Call for Methods have Standard Method Performance Requirements (SMPRs®) associated with them.

Method submissions must include a manuscript in AOAC format. This includes formatting of the method under consideration within the manuscript. You will still be able to submit data files. This is mandatory for methods being considered for either First Action and Final Action *Official Methods of Analysis* (OMA) status.
