AOAC SPIFAN NUTRIENTS "CALL FOR METHODS"

(METHOD SUBMISSION DEADLINE)

AOAC invites method developers to submit methods for consideration and possible evaluation through the AOAC *Official Methods* program. Prospective methods must be able to determine the following in all forms of infant, adult, and/or pediatric formula (powders, ready-to-feed liquids, and liquid concentrates) according to each nutrient's standard method performance requirements (SMPR®).

The submission deadline date for ALL methods (including candidate First Action, modifications, and multi-laboratory testing) to be reviewed is **Friday, February 26, 2021**.

- 1. Carotenoids (alpha-carotene & lutein)
- 2. Fluoride
- 3. Human Milk Oligosaccharides (HMO) (2'-FL & LNnT)
- 4. Lactoferrin
