	Description	FEE
Level 1	Editorial changes that do not alter the performance of the validated method. EXAMPLES: <i>Editorial addition and/or revision to marketing /labeling / insert materials</i>	\$1,500
Level 2	Minor modification that impacts method claim or improves validated method function. Method Developer data required. EXAMPLES: Manufacturing location change, change in raw material component, removal of chemical for compliance, non-critical workflow change, some matrix extensions.	\$5,000
Level 3	Major modification to the validated test method components and/or workflow. Method developer and independent laboratory testing required. EXAMPLES: Revision to testing procedure, addition of a reference method, critical reagent and/or extractions, some matrix extensions	\$10,000
Multiple Modification Discount for Identical Modification/Extensions	Level 1: <i>One Application</i> <i>Group submission- 3 or more methods</i>	\$1,500 \$4,500
